Sub: Allotment of 8,85,000 equity shares upon conversion of convertible warrants

Dear Sir/Madam,

This is with reference to 60,00,000 convertible warrants of Rs.152 each allotted by the Company on March 13, 2015, on preferential basis to Promoter Group Entities, convertible into equivalent number of equity shares before the expiry of 18 months from the date of allotment of warrants upon payment of balance 75% of the consideration of warrants.

In this regard we would like to inform that holders of 8,85,000 convertible warrants have paid the balance 75% of the consideration aggregating Rs.10,08,90,000 and exercised their right of conversion.

Therefore, pursuant to the above, Special Committee of the Board of Directors constituted for this purpose, had, in its meeting held today i.e. January 29, 2016, issued and allotted 8,85,000 equity shares of Rs.10 each at a premium of Rs.142 each. The details of allotment are as follows:


